Graduate School Excellence in Doctoral Student Mentoring Award ---CAPPA, COB, COLA, EDUC, & SSW Faculty--

Deadline for nominations: Friday, January 12, 2024

PURPOSE

The Excellence in Doctoral Student Mentoring Award is intended for faculty members who have a strong record of excellence in mentoring doctoral students. Effective mentoring is a crucial determinant of the academic and professional success of a graduate student and this award is intended to provide the UT Arlington community the opportunity to publicly acknowledge and reward outstanding mentors. The Graduate sShool solicits nominations for the Award from the STEM disciplines or from the Liberal Arts and Professional disciplines in alternating years. This year, nominees from CAPPA, COB, COLA, EDUC and SSW will be considered for this award.

A panel consisting of faculty, doctoral students, and Graduate School Leadership will review nominees and select one graduate faculty member who excels as a mentor to graduate students. The selected individual will receive \$3000 and will be recognized at the Spring Meeting of the University Faculty and Associates. The recipient's essay on his/her mentoring philosophy and a brief biographical sketch describing his/her work and career will be featured on the graduate school's website.

ELIGIBILITY

To qualify for the award, nominees must currently be a full-time, tenure-track or tenured UT Arlington faculty member from CAPPA, COB, COLA, EDUC or SSW who has chaired the committee of at least three (3) doctoral recipients in the last eight (8) years. Past recipients may be nominated eight (8) years after receiving the award, but preference will be given to faculty members who have not previously received this award.

CRITERIA FOR SELECTION

Nominees should exhibit the following characteristics:

- 1. Promotes successful completion of students' research and degree programs by monitoring progress and offering honest, constructive feedback when needed or sought;
- 2. Commits to advancing students' long-term professional development and integrates students into the broader culture of the discipline;
- 3. Ensures that students master the content and skills of their discipline, including the ability to teach or present content to professional and non-professional audiences;
- 4. Creates a supportive environment for research and scholarship by fostering mutual respect and demonstrating sincere and active interest in the well-being of the student;
- 5. Maintains accessibility by providing consistently open lines of communication;
- 6. Connects students with the resources necessary to take full advantage of academic and professional opportunities and enables students by helping them to develop their own local and national networks; and
- 7. Models a solid record of scholarship marked by excellence in research and teaching skills, research presentation and publication, the ability to obtain funding, and the exercise and nurturing of good mentoring practices.

NOMINATION PROCESS

UT Arlington doctoral students and faculty are invited to nominate a qualified faculty member for the Award by completing the nomination form located at https://resources.uta.edu/gradschool/awards/nomination-form.php .

Nominated faculty will be contacted by the Graduate School and asked to submit required supporting materials if they wish to be considered for the award. These materials are described in the attachment titled **2023-2024 Doctoral Award- Application Process.pdf**.

Nomination Deadline

The initial nomination form is due **January 12, 2024.** Supporting documents from nominees who wish to be considered <u>must</u> be received by the graduate school no later than 11:59 pm on **February 16, 2024**
