

Regulatory Services supports academic research by assuring institutional and investigator compliance with applicable regulations, policies, and industry standards in regulated research or scholarly activities. Regulatory Services is committed to enhancing the research enterprise of the University by focusing on outreach and guidance, developing efficient programs to process research activities, and promoting ethical conduct of research.



#### SERVICES AND GUIDANCE PROVIDED IN THE FOLLOWING AREAS



Meeting federal and institutional regulatory requirements for research activities involving <u>human subjects</u>, <u>live vertebrate animals</u>, <u>recombinant/synthetic nucleic acids</u>, and <u>research conflicts of interest (RCOI)</u> including obtaining applicable University research approvals through the <u>Institutional Review Board for Human Subjects</u> (<u>IRB</u>), <u>Institutional Animal Care & Use Committee (IACUC)</u>, <u>Institutional Biosafety Committee (IBC)</u>, and the <u>RCOI Committee respectively</u>.



Developing safeguards, performing screening, and meeting applicable license requirements for <u>foreign</u> <u>collaborations</u>, <u>international shipments</u>, <u>international travel</u>, and <u>export controlled</u> activities involving software, data, and technology subject to the Export Administration Regulations (EAR), the International Traffic in Arms Regulations (ITAR), and the Office of Foreign Assets Control's sanctions programs.



Making available resources and training in the <u>responsible conduct of research</u> as established by the federal Office of Research Integrity (ORI).
